Notes: Businesses are organized by the company name as written, but individual names with no evidence of being a trade or business name will be written as surname followed by comma and initials.

Companies who have multiple receipts for the different individuals or address, will be organized alphabetically by Last Name, First Name and be denoted with the addition of a Memo. Example (986.86.002.003a.001 – Brantford Gas Co. – Foster, George; 986.86.002.003b.001 – Brantford Gas Co. – Olive, A. G.)

Where 2 receipts from the same company on the same date to the same person and address exist, the receipt noting the smaller denomination will be catalogued first.

In the eventuality that both receipts and business communication are found in the same envelope, receipts will be catalogued alphabetically, followed by communication in a separate alphabetized list.

These conventions will be uniform across the collection.
